- 2. When any contest has a deadline for entry, the deadline is clearly indicated in on-air promotional announcements and any written rules or directions.**
- 3. Contests and promotions are open to listeners ages 18 or older unless otherwise indicated.**
- 4. The radio station reserves the right to limit the winning of prizes to once every 30 days per household.**
- 5. Winners are responsible for all federal, state and local taxes, if any. All federal, state and local laws apply.**
- 6. No purchase is necessary to participate in contests and promotions.**
- 7. There are no prize substitutions. Prizes are non-transferable and are not negotiable. Prizes can't be exchanged for cash.**
